1.	<b>Application form</b> duly filled in and signed by the applicant.		
2.	1 recent passport size <b>photograph</b> (must be made within previous 3 month) in color with white background (3,5 by 4,5 cm).		
3.	<b>Passport</b> /travel document must: a) have a validity of at least 3 months after the intended stay b) be issued within the previous 10 years c) have 2 blank pages. (It is recommended to attach old passports.)		
4.	Return <b>flight ticket</b> reservation. (in accordance with insurance and accommodation)		
5.	Overseas <b>travel medical insurance</b> valid for all Schengen countries. The insurance has to cover the applicant for at least 30,000 euros or equivalent, for all risks e.g. accident, illness, medical emergency, etc.		
6.	Official translation of <b>birth certificate</b> (Shenasname) of parents and students.		
7.	<b>Letter of invitation</b> issued and endorsed by the National Directorate-General for Aliens Policing (except for parents).		
8.	Copy of the Hungarian <b>residence permit</b> and address card of the student.		
9.	<b>Student status certificate</b> by the institution where the student is studying ( <b>of the latest semester</b> ).		
10.	<b>Accommodation</b> for the whole period of stay. Copy of the Hungarian lease contract and permission of the landlord. In case of non-private owner an authorized permit (with proof of entitlement).		
11.	<b>Employer's certificate</b> needs to contain the following: job title, address, starting date of employment, monthly amount of income and <b>salary slip</b> of the last three months. Formal requirements: letterhead paper, stamp, and corporate signature. <b>Certificate from Social Security Organization</b> also recommended. In case of self-employment, certificate of registration. / For students, certificate from school (from the latest semester). / For pensioners, Pension slip of the last three months.		
12.	Detailed <b>bank account statement</b> of the past three months.		
13.	For minors a declaration by the legal representative on the coverage of the costs certified by notary public. If travelling alone or with one parent (legal representative), minors are requested to present a declaration from the legal representatives / other legal representative.		
14.	<b>Title deed</b> (if you own property).		
15.	Copy of the passport and <b>previous Schengen visas</b> .		

NOTE: Visa fee is 80 EUR // if applied VFS, additional 26 EUR service cost  
**Issuing the visa is subject to the submission of the documents listed.** The Embassy reserves the right to request further documentation.  
If the documents are not English, **you need to have them translated.**  
Original documents and its **copies also must be submitted.**  
**We would like to inform you that traveling differently from a pre-approved route may impact your next visa application negatively!**
